## Report on the Lecture: "Terrorism and Its Financing: A Focus on Kashmir"

The heart of the lecture centred on case studies of terrorist attacks in Kashmir, where Dr. Pandya provided a detailed analysis of key incidents, including the 1989 insurgency, which triggered an intense wave of violence in the region. He emphasized the complex interplay of local grievances, external influences, and global geopolitical factors, stressing that a localized

understanding of terrorism in Kashmir is essential. Viewing the issue solely through a global lens would fail to capture the intricate dynamics fueling regional conflicts.

In parallel with these case studies, the speaker introduced his latest book, "Terror Financing in Kashmir." He explained that the book aims to uncover the financial networks that sustain terrorism in the region. Dr. Pandya described how various sources, including state sponsorship, illicit trade, and local donations, enable terrorist groups to operate effectively. He argued that disrupting these financial networks is critical for any successful counter-terrorism strategy and shared recommendations from his book on how policymakers could address these challenges.

During the Q&A session, the audience engaged actively, raising questions about the role of international actors in Kashmir and the implications of the speaker's findings for global counter-terrorism efforts. Dr. Pandya's responses highlighted the necessity for collaborative approaches that take into account local contexts while tackling the broader global implications of terrorism.
